ADMISSION PROCEDURE 2023-24

The Admission Brochure will acquaint you with relevant and requisite information for admission to various courses offered at SBS University. It contains detailed information pertaining to Admission Process and Fee Structure. Sardar Bhagwan Singh University is a Sikh Minority University, wherein 50% seats are reserved for Sikh students as per policies in vogue. However, admissions are open to students of general and all other categories, irrespective of religion, caste or creed.

The University also awards scholarships & concessions to the meritorious students, students from Uttarakhand, Sikh minority candidates and sports persons who have excelled at State/National level. Details of the scheme are given in Para 8.0.

1.0 SELECTION PROCEDURE FOR ADMISSION TO ALL DIPLOMA, UG AND PG COURSES (Including Tuition Fee Waiver Seats)

All candidates are to apply on prescribed format of the University along with processing fee of Rs. 1580/and relevant documents. All admissions for the Academic session 2023-24 shall be on the basis of merit of marks obtained by the student in previous qualifying examination.

1.1 LATERAL ENTRY B.PHARM & BPT 2nd YEAR:

Eligibility: Diploma holders with minimum 50% marks.

10 % of approved intake in B.Pharm/BPT shall be filled on the basis of -

- (1) Marks obtained in Diploma in Pharmacy/Physiotherapy and counseling.
- (2) Marks of weightage, if applicable will be added to the overall merit. (Refer Para 8.2)

1.2 ADMISSION TO Ph.D. PROGRAMMES

The University offers Ph.D. programmes in Pharmacy, Life Sciences, Allied Health Sciences and Basic Sciences. All candidates are to apply on prescribed format of the University along with processing fee of Rs. 2080/- and relevant documents as per Para 3.0 to be attached with application. All candidates except those possessing qualifying scores in GATE/GPAT/UGC-NET shall be required to qualify the Entrance Examination conducted by the University in **July and December** every year. The dates of the examination shall be notified on University website.

In addition, 5% of intake capacity will be (D)reserved under supernumerary quota for Kashmiri Migrant Students.

7.0 CANCELLATION OF ADMISSION

Students not desirous of admission in the University after completing admission process due to any reason must inform the University in writing for cancellation and must obtain cancellation letter for the same.

7.1 TRANSFER OF ADMISSION TO ANOTHER COURSE

- a) **During Process of Admission and Before Commencement of Class.** The transfer will be allowed on availability of seats in the desired course. A processing fee of Rs. 500/- shall be charged for the same.
- B) **After Commencement of the Course**. All cases shall be treated as withdrawal and readmission.

Deduction as per procedure of withdrawal shall be applicable.

8.0 SCHOLARSHIPS & CONCESSIONS

- **Covid Specific Relief : -** Special waiver of 50% in tuition Fee for applicants who lost their Earning Head/ Family Head during Covid-19 Pandemic.

RULES AND REGULATIONS

Not withstanding anything contained in any other bulletin of information, the provisions of this section shall prevail and shall be binding on all concerned. All students shall be presumed to have read and understood the contents of this section. No plea shall be entertained by a student that he/she did not read this bulletin or that he/she relied upon any other bulletin, etc. issued or published by the University.

- 1. On Admission to the Course of study, every student submits himself/herself to disciplinary jurisdiction of the management of the University. The VC and other Officers of the University who may be vested with the authority to exercise discipline under Uttaranchal State Universities Act and Ordinance, Rules and Regulations that have been or will be framed by the University
- 2. Candidates have to fulfill the minimum attendance requirements as given in the Ordinance for each course. No student will be absent himself/herself from any of the lectures without leave having been obtained previously from the Incharge of the centre and that too for substantial/compassionate cause, and if he/she is irregular in attendance, or fails to show progress or is not diligent in studies, his/her name is liable to be struck off from the rolls of the University. In the case of a candidate who joined late owing to late declaration of results or who sought admission provisionally till declaration of the lower examination, the lectures etc. shall be counted from 10 days after the declaration of the result or the date of his joining, whichever is earlier.
- 3. If a student fails to attend his/her classes continuously for four days from the date of commencement of the classes (date of marking of attendance) his/her admission will stand cancelled
- 4. Attendance of students on the following special occasions is mandatory and the defaulters will be penalized.
- a) Independence Day
- b) Republic Day
- c) Annual Day
- d) Any special function organized by the State/University

MAINTENANCE OF DISCIPLINE ORDINANCE A:

- 1. All powers relating to discipline and disciplinary action are vested in the Vice Chancellor of the University.
- 2. The Vice-Chancellor may delegate all or such powers as he/she deems proper to any of the official of the University.
- 3. Without prejudice to the generality of power to enforce discipline under the ordinance, the following shall amount to acts of gross indiscipline:
- a) Physical Assault or threat to use physical force against any member of the teaching, non-teaching staff of the University and against any student within the campus, Public Transport or surrounding villages of the University.
- b) Possession or threat to use of any weapon
- c) Any violation of the provisions of the Civil Rights Protection Act 1976.
- d) Violation of the status, dignity and honour of the students belonging to the Scheduled Castes and Scheduled Tribes.
- e) Any practice whether verbal or otherwise derogatory to women.

- f) Any attempt of bribery of the University's staff.
- g) Willful destruction of the University's property.
- Keeping of mobile phones within the University's academics premises is banned and if found, the mobile be confiscated and the individual shall be fined for violations of Rules & Regulations.
- i) Creating ill-will or intolerance on religious or communal grounds.
- j) Causing disruption in any manner of the academic functioning of the University.
- K) Ragging as per Ordinance (B)
- 4. Without prejudice to the generality of his powers relating to the maintenance of discipline and taking such action in the interest as may deem to him appropriate, the Vice-Chancllor may, in the exercise of his/her powers aforesaid order or direct:
- a) That any student or students be expelled, or
- b) Any student or students be, for a stated period, rusticated, or
- Not allowed to attend a course of study in a department of the University for a stated period.
- d) Be fined(to be specified)
- e) Be debarred from giving a departmental examination or University Examination.
- f) That the result of the students concerned in the examination or examinations in which he/she appeared be cancelled.
- The University's Authorities shall have authority to exercise all such disciplinary powers over students as they may find necessary for proper conduct of the University.
- 6. Without prejudice to the powers of the Vice chancellor, detailed rules of the discipline and proper conduct in class rooms/laboratories/ University campus may be supplemented where necessary by Vice chancellor of the University or Heads of Departments. Each student shall be expected to study and follow these rules.
- 7. At the time of admission, every student shall be required to sign a declaration that on admission he/she submits himself/herself to the disciplinary jurisdiction of the Vice - chancellor and other authorities of the University who may be vested with the authority to exercise discipline under the rules and regulations that have been framed by the University.

NOTE: Parents/Guardians are advised not to encourage their ward to remain absent without substantial/compassionate reasons during the academic session. Medical leave will be granted strictly only as per the University's Medical Leave Rule for the students.

Vice-Chancellor's Order

All students must be informed that upon a statement by the teacher or others engaged in teaching or in the conduct of examinations that in putting threat or use of force, the student(s), and examinee (s) will be suspended for a specified period or expelled by the University under ordinance 1(A). Persons so dealt with will be entitled to a post decision hearing.

ORDINANCE B:

- Ragging in any form is strictly prohibited, within premises of the University/Public Transport/surrounding village of the University.
- 2. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under this ordinance.
- 3. Ragging for the purposes of this ordinance, ordinarily means any act, conduct or practice by which dominant power or status or senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by the other students and includes individual or collective acts or practices which:
- a) Involve physical assault or threat or use of physical force.
- b) Violate the status, dignity and honour of female students.
- c) Violate the status, dignity and honour of students 'belonging to the Scheduled Castes and Scheduled Tribes.
- d) Expose students to ridicule and contempt and affect their selfesteem.
- e) Entail verbal abuse and aggression, indecent gestures and obscene behavior.
- The Head of Department and other authorities of the University shall take immediate action on any information of the occurrence of ragging.
- 5. Not withstanding anything in Clause (4) above, The Head of Department or any other staff member may also enquire into any incident of ragging and make a report to the Vice-Chancellor of the identity of those who have engaged in ragging and the nature of the incident. The concerned students will be given liberty to explain and if his explanation is not found satisfactory the authority would expel him from the Institutions.
- 6. The Head of the department or any other staff member may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident to the Vice-Chancellor.
- If the Head of Department or Administrative Officer or Vice -Chancellor is satisfied that for some reason, to be recorded in writing, it is not reasonably practical to hold such an enquiry, he/she may so advice the Vice - Chancellor accordingly.
- 8. When the Vice chancellor is satisfied that it is not expedient to hold such enquiry, his decision shall be final.
- 9. On the receipt of a report under(5) or (6), a determination by the relevant authority under clause(7) disclosing the occurrences of ragging incidents describe in clause 3(a),(b) and(c), the Vice - chancellor shall direct or order rustication of student(s) for a specific number of years.
- 10. The Vice Chancellor may, in other cases of ragging, order or direct that any student or students be expelled or be not for a stated period, admitted to a course of study in the University. Departmental Examination for one or more years or that the result of the student or students concerned in the examination in which they appeared, be cancelled.
- 11. For the purpose of this ordinance, abetment to ragging will also

- amount to ragging.
- 12. All authorities including faculty members of the University shall be obligated to carry out instructions/directions issued under this ordinance and to give aid and assistance to the Vice chancellor to achieve the effective implementation of the ordinances.

ORDINANCE C:

UNIFORM

It is compulsory for all students to wear the prescribed uniform while in the campus.

- For Boys: Summer- White Shirt, Grey Pants, Black Shoes and University's Tie (Turban- Navy Blue for Sikh students)
 Winter- White Shirt, Steel Grey Pants, Black Shoes, Blazer- Navy Blue with University's Monogram and University's Tie (Turban- Navy Blue for Sikh students)
 *Blazer design shall be in uniformity as per approved sample by the management.
- For Girls: Summer- White Salwar Kameez with white Dupatta, Black Shoes/Black Sandals
 Winter- White Salwar Kameez with White Dupatta or White Shirt and Steel Grey Trouser, Navy Blue Blazer with University's Monogram, Navy blue Pullover, Black Shoes/Black Sandals
- White Lab Coat is necessary for all the students working in the Laboratory.

Wearing of identity card issued by the University is mandatory.

If any student violates the Dress Code:

He/she will not be allowed to enter in the University's campus. He/she may be fined.

His/her library card can be cancelled for a specified period. Action may be taken against such student(s) as per provisions of Ordinance (A)

ORDINANCE D:

Payment of Fee.

i. For New Entrants

Fee and other dues must be paid by the candidate selected for admission by the date specified. If any candidate fails to pay the fees by the day specified / grace period, his/ her selection for admission will automatically stand cancelled and the vacancies so caused will be filled in from the candidates next in the order.

ii. For other Students

Fees and other dues must be paid by all the students by 30th June &31st December each year, failing which:

- a) They will be required to pay fee enhanced by Rs. 1000/- up to 15 day and by Rs. 5000/- thereafter till 30 days.
- After 30 days, the name of the defaulting student shall be struck-off from the rolls of the University which shall be revoked only after payment of readmission fee of Rs. 5000/- (Rs. Five thousand only)

Refund Rules:

- 1. Refund of the fee will be subject to deduction of Admission Fee.
- However, if withdrawal is after commencement of classes and during the continuation of the academic session till 15th September, fee will be refunded after further deductions to be decided by a committee.
- 3. Refund after last date of admission i.e. 15th September shall not be considered under any circumstances.
- 4. In case of withdrawal during the course, the student shall have to deposit entire course fee.
- Admissions under extraordinary circumstances may also be held beyond the scheduled last date of admission, refund rules in these cases or otherwise shall be considered as per rules in voque.
- 5. All refund cases shall be processed after 15th Nov.

ORDINANCE E:

Stay in Hostels is mandatory for outstation girls & boys. Local students may be exempted. Students staying in the jurisdiction of Mahanagar Nigam shall be considered as locals, provided they submit their Ration Card/Eectricity Bill/Telephone Bill as proof of residence. Wards of Govt. Officials have to give their proof of posting at Dehradun. However, students residing in Rishikesh can be permitted upon producing an undertaking by parents/guardians.

ORDINANCE F:

Examinations

- All students who are unable to successfully complete their Annual/ Semester Programmes & wish to Reregister, should fill up the Re-registration form within a week of declaration of results along with 10% of the tuition fee.
- Students who successfully complete their Annual/ Semester programmes are required to fill up Registration form for next higher class, within a week of declaration of results.
- All students are required to collect their mark sheets from the Examination Department after submitting "No Dues Certificates" from different departments of the University.
- 4. Students who could not appear in Sessional examinations as per University regulations shall not be allowed to appear in University Examinations.
- 5. All students who do not fulfill the compulsory criteria of 80% attendance in all subjects shall not be allowed to appear in Sessional and University Examinations.


Discipline: A system of Black Dots for act of indiscipline has been introduced in the University Campus & Hostel, depending on the severity of in disciplinary act, the student will be awarded 2-4 black dots. A student who has accumulated 4 black dots will be rusticated for a specific period from the University. The issue of character certificate to the students who earned black dots will be at the discretion of the Vice Chancellor.
